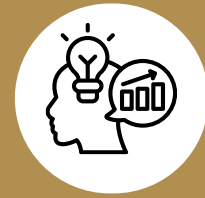

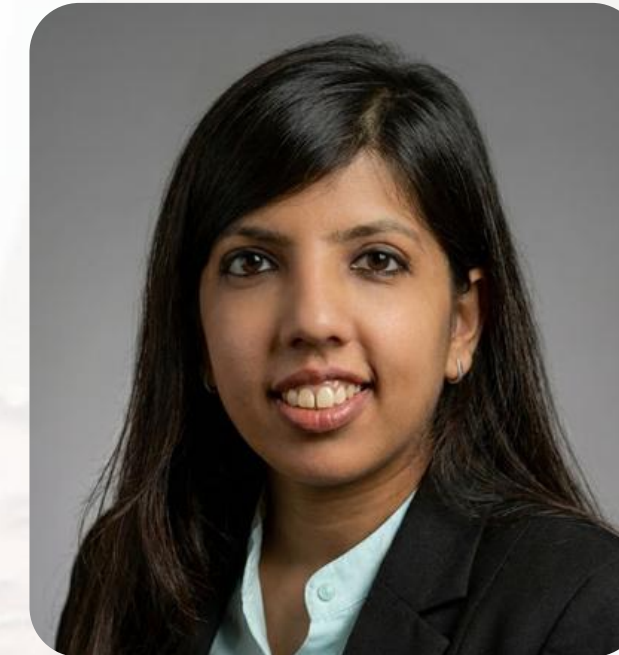
Nabin has worked on various facets of tax & regulatory matters including cross border transactions, outbound structuring, tax litigation strategy & representation, business restructuring and tax planning.

He is a part of the GST Committee at state level for resolution of industry issue at large. He is currently holding the position of President of ITAT Bar Association.

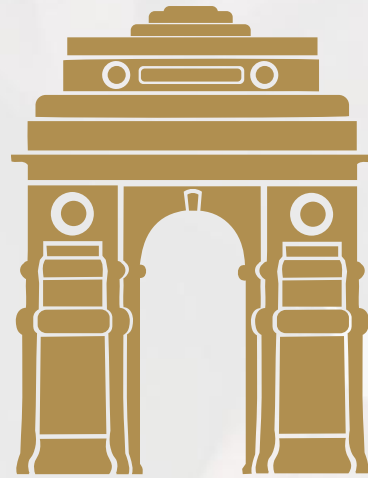


Prerna Chopra
